Selected Projects

ICEG European Center has participated in various international and national research projects. Some of them are presented briefly below.

REGIONAL ASPECTS OF COMPETITIVENESS

Related to the preparation of the Competitiveness Strategy, this research program assessed the factors determining growth and competitiveness of the 7 NUTS-II regions in Hungary. Within the project broad-based studies and assessments were prepared on the institutional, supply-side factors of growth, the major strengths and weaknesses of the regions' competitiveness. Based on these assessments suggested areas for policy the studies intervention, especially in relation to the use of EU and local development funds.

The summary study assessed the differences and similarities between the regions in terms of their factors of growth, required policy measures and proposed a framework for dividing region related development funds between the sectoral and regional Operative Programmes in the 2007-2013 budget periods.

COMPETITIVENESS STRATEGY

ICEG European Center - together with her partners - assessed in this project the factors of competitiveness of the Hungarian economy. The main goals of the research were to determine what are the major driving factors of Hungary's competitiveness, what is the contribution of economic policies to competitiveness and what should be the optimal use of Structural and Cohesion Funds to strengthen competitiveness.

Within the framework of the project background studies were prepared on the supply-side, institutional and policy related factors of competitiveness, on the lessons that can be learned from the experiences of successfully converging economies and about short- to medium-term policy measures that should be implemented in Hungary to increase competitiveness of the economy.

PAPERS ON ENERGY POLICY

Two papers on energy policy were written, which were eventually published by the client in order to improve the knowledge of economic policymakers on the energy industry. The first study assessed the technological and economic characteristics of the electricity industry, summarized the main theoretic reasons and intervention, practical methods state of compared different models of electricity systems and reviewed the international experience of electricity market liberalisation. The second paper described the main models of wholesale electricity trade with special focus on the role of energy exchanges in Western European countries. Both papers were written in Hungarian.

NATIONAL BROADBAND STRATEGY 2005

ICEG European Center has participated in the project initiated by the Ministry of Informatics and Communication titled "National Broadband Strategy 2005". We have prepared two studies, "Evaluation of macroeconomics effects of broadband development in international comparison and in Hungary" and "International best practice in broadband policy".

KRYNICA ECONOMIC FORUM 2005

On 9 September 2005, as part of the International Economic Forum in Krynica, Poland, a special session on Information Society and the role of ICT in the New Member States has been organised jointly by IPTS (Institute for Prospective Technological Studies, DG Joint Research Centre, European Commission) and ICEG EC.

FINANCIAL SUMMIT II

The purpose of the conference was to discuss the most important questions, open problems and alternative opinions concerning the structural reform of public finances.

Mr Istvan Stumpf and Mr. Lajos Bokros were the main speakers of the conference. The agenda also included the reform of human infrastructure, pension system, healthcare, tax system and legal infrastructure. For the first time, leading representatives of foreign embassies shared their opinions about the current assessment of our country and the needed reform measures.

THE GLOBAL ECONOMY, THE EURO ZONE, AND THE NEW MEMBER STATES, A REGIONAL PERSPECTIVE ON THE IMF'S WORLD ECONOMIC OUTLOOK

Ms. Schadler and Mr. Rosenberg presented the highlights of the IMF's World Economic Outlook - a review of global economic developments and near-term projections which will be released in late-September—focusing on the implications for the economies of Central Europe and the Baltic's.

COMPETITIVENESS IN THE NEW MEMBER STATES: THE CASE OF HUNGARY

The Confederation of Hungarian Employers and Industrialists and ICEG European Center organised a conference on 18th of November 2005, in the European Economic and Social Committee, Brussels. The aim of the conference was to overview the competitive strengths and weaknesses of the New Member States, with a special regard to Hungary. The invited speakers evaluated the position of Hungary in comparison with the New Member States and EU 15 with regard to the Lisbon indicators, FDI and relocation of investments, the region's wage, cost and price competitiveness and the role of ICT in enhancing competitiveness.
